INFORMATION ACADEMIC NORMS AND RULES OF CONDUCT

- Practical Work to be performed by the each student is compulsory as per D.El.Ed. I st Year Course norm i.e. compulsory school experience for 10 days, school teaching for 50 days and computers practical, Yog Practical, Arts Practical & Project preparations should be observed regarding the same.
 Only after completion of the above, students can appear in D.El.Ed. First Year Final Theory & Practical Examination 2020.
- 2. Attendance of every student will be done daily on registers and also online in the morning and evening sessions as per SCERT norms. For appearing in final examinations it is compulsory for the student to maintain 85% attendance in total scheduled 240 working days as per course norms, otherwise he will not be permitted to appear in the final examinations if the students will be found absent without any information for more than 07 days the students name will be struck off from the college rolls.
- 3. Every student shall attend classes and complete his practical part in college uniform and shall also carry the college identity card daily and produce it on demand.
- 4. <u>All the notices shall be displayed on the notice board in the college .lt will be students responsibility to check notice board regularly</u>.
- 5. All the students are advised to maintain the same telephone no./Whatsup number during the tenure of their degree to avoid any inconvenience.
- 6. The Students should co-operate in keeping the college neat and clean.
- 7. Students who willfully or otherwise damage college property will be severely dealt with, Smoking in the college premises is strictly prohibited.

Undertaking Regarding Prohibition of Ragging from Students & Guardian

In view of the directions of the Honorable Supreme Court of India in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009, In Viswa Bharathi Institute Ragging is strictly prohibited and the principal / Head is responsible to prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in the institution.

Ragging consists of one or more of any of the following acts:

- 1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- 2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- 3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- 4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- 5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- 8. Any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;

9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
